At Barlean's Organic Oils, LLC ("Barlean's"), we are committed to you—the resellers that help our company satisfy customer needs and deliver best-in-class health and nutritional supplements. To protect our brand and the integrity of our authorized distribution channels, Barlean's is announcing and implementing an Authorized Reseller Program, effective **June 30, 2021**.

Among other benefits, our Authorized Reseller Program will ensure that all sellers of Barlean's® products (collectively, the "Products") understand and take the steps necessary to ensure product quality and provide the excellent customer service that is integral to the reputation of our brands. In addition, our Authorized Reseller program will assist us in identifying and taking action against unauthorized sellers that are harming you, the Barlean's, and consumers through the sale of damaged, diverted, and otherwise poor-quality products.

Your obligations under our new Authorized Reseller Program are outlined in the attached **Barlean's Organic Oils, LLC Authorized Reseller Policy for the United States ("Authorized Reseller Policy")**. Please note that you are expected to comply with the terms of the enclosed Authorized Reseller Policy to remain an "Authorized Reseller" of Products. The key features of the Authorized Reseller Policy are noted below:

- **Where and To Whom You May Sell Our Products:** The Authorized Reseller Policy requires that you sell Products solely to end users and not to persons or entities who intend to resell our products. You also may not market for sale or ship these products outside of the United States without our prior written consent.
- **Limitations on Online Sales:**
  - If you are a healthcare professional who purchases Products from a Barlean's Authorized Distributor, you are permitted to sell Products through an ePharmacy (as defined in the Authorized Reseller Policy) that is operated by a Barlean's Authorized Distributor.
  - **You are not permitted to sell Products on or through *any* other website, online marketplace (including, but not limited to, Amazon, eBay, Walmart Marketplace, Target+, Facebook Marketplace), mobile application, or other online forum without receiving the prior written consent of Barlean's. Our rules regarding online sales will be strictly enforced.**
- **Ensuring Product Care and Customer Service:** To ensure that the end user consumers who purchase our Products have the best experience possible, the Authorized Reseller Policy provides certain steps that you must take to maintain the quality of our Products. The Authorized Reseller Policy also outlines our expectations for the service you must provide to your customers.

Finally, Barlean's has a unilateral Minimum Advertised Price Policy ("MAP Policy"), which applies to all authorized sellers of Products in the United States. A copy of the MAP Policy, which will be effective on June 30, 2021, is attached for your review and reference.

**BARLEAN'S ORGANIC OILS, LLC**  
**AUTHORIZED RESELLER POLICY FOR THE UNITED STATES**  
**Effective Date: June 30, 2021**

This Barlean's Organic Oils, LLC Authorized Reseller Policy for the United States ("Reseller Policy") is issued by Barlean's Organic Oils, LLC ("Barlean's") and applies to Authorized Resellers of Barlean's® products ("Product(s)") in the United States of America. By purchasing Products from Barlean's or an Authorized Barlean's Distributor for retail sale, you ("Reseller") agree to adhere to the following terms. Until such status is otherwise revoked by Barlean's in the sole and absolute discretion of Barlean's, Reseller shall be considered an "Authorized Reseller." Barlean's may review Reseller's activities for compliance with this Reseller Policy, and Reseller agrees to cooperate with any such investigation, including, but not limited to, permitting inspection of Reseller's facilities and records related to the sale of the Products.

1. **Authorized Customers.** Reseller is authorized to sell Products only to End Users. An "End User" is a purchaser of the Products who is the ultimate consumer of the Products and who does not intend to resell the Products to any third party. Reseller shall not sell or transfer Products to any person or entity Reseller knows or has reason to know intends to resell the Products. Reseller shall not sell or transfer a quantity of the Products to any individual greater than that typically purchased for personal use. Reseller shall not sell, ship, or promote the Products outside the United States of America without the prior written consent of Barlean's.

2. **Online Sales.**

(a) Resellers that are a health care professional with a license/certification (if required by law) or a business entity that has a healthcare professional as an owner, member, operator, manager, director, or other similar authority involved in the sales of Products are authorized to sell the Products on an "ePharmacy" that is operated by a Barlean's Authorized Distributor on behalf of the Reseller. An "ePharmacy" is a website, micro-site, or mobile application that (i) is operated by the Authorized Distributor in its legal name or registered fictitious name, (ii) is primarily used to facilitate Product orders from End Users on behalf of health care professional Resellers, and (iii) requires the prospective End User to create an account and log-in to purchase the Products.

(b) **Reseller shall not offer for sale or sell Products on or through any website, online marketplace (including, but not limited to, Amazon, eBay, Walmart Marketplace, Target+, Facebook Marketplace), mobile application, or other online forum other than an ePharmacy without the prior written consent of Barlean's, granted through execution by Barlean's of the Barlean's Organic Oils, LLC Authorized Online Seller Agreement.** The terms of this Reseller Policy supersede any prior agreement between Barlean's and Reseller regarding the sale of the Products on or through websites, mobile applications, and other online forums. Any authorization previously granted to Reseller by Barlean's to sell the Products on or through a website, mobile application, or other online forum is revoked.

(c) Barlean's reserves the right to terminate, at any time and in its sole discretion, its approval for Reseller to market and sell Products on any ePharmacy, and Reseller must cease all such marketing and sales on the ePharmacies immediately upon notice of such termination. The terms of this Reseller Policy supersede any prior agreement between Barlean's and Reseller regarding the sale of the Products online. Any authorization previously granted to Reseller by Barlean's to sell the Products on or through any other website, mobile application, or other online forum is revoked.

3. **Sales Practices.** Reseller shall conduct its business in a reasonable and ethical manner at all times and shall not engage in any deceptive, misleading, or unethical practices or advertising at any time. Reseller shall not make any warranties or representations concerning the Products except as expressly authorized by Barlean's. Reseller shall comply with all applicable laws, rules, regulations, and policies (a) applicable to Reseller's business and/or (b) related to the marketing and sale of the Products. Reseller shall represent the Products in a professional manner and refrain from any conduct that is or could be detrimental to the reputation of Barlean's or the Products. Reseller shall not advertise Products not carried in inventory.

4. **Product Care, Customer Service, and Other Quality Controls.** Reseller shall comply with the Barlean's Organic Oils, LLC Product Care, Customer Service, and Other Quality Controls, attached as Exhibit A, as Barlean's may amend from time to time.

5. **Intellectual Property.**

(a) Reseller acknowledges and agrees that Barlean's owns all proprietary rights in and to the Barlean's brand, names, logos, trademarks, service marks, trade dress, copyrights, and other intellectual property related to the Products (the "Barlean's IP"). Reseller is granted a limited, non-exclusive, non-transferable, revocable license to use the Barlean's IP solely for purposes of marketing and selling the Products as set forth herein. This license will cease upon termination of Reseller's status as an Authorized Reseller. All goodwill arising from Reseller's use of the Barlean's IP shall inure solely to the benefit of Barlean's.

(b) Reseller's use of the Barlean's IP shall be in accordance with any guidelines that may be provided by Barlean's from time to time and must be commercially reasonable as to the size, placement, and other manners of use. Barlean's reserves the right to review and approve, in its sole discretion, Reseller's use or intended use of the Barlean's IP at any time, without limitation. In marketing the Products, Reseller shall only use images of Products either supplied by or authorized by Barlean's and shall ensure that all Product images and descriptions are accurate and up to date.

(c) Reseller shall not create, register, or use any domain name, social media screenname, or mobile application name that contains any Barlean's product name or trademark, nor a misspelling or confusingly similar variation of any Barlean's product name or trademark.

6. **Termination.** Barlean's reserves the right to terminate Reseller's status as an Authorized Reseller with written or electronic notice. Upon termination of a Reseller's status as an Authorized Reseller, Reseller shall immediately cease (i) selling the Products; (ii) acting in any manner that may reasonably give the impression that Reseller is an Authorized Reseller of Barlean's Products or has any affiliation whatsoever with Barlean's; and (iii) using all Barlean's IP.

7. **Modification.** Barlean's reserves the right to update, amend, or modify this Reseller Policy at any time. Unless otherwise provided, such amendments will take effect immediately, and Reseller's continued use, advertising, offering for sale, or sale of the Products, use of the Barlean's IP, or use of any other information or materials provided by Barlean's to Reseller will be deemed Reseller's acceptance of the amendments.

8. **Confidentiality.** This Reseller Policy, and its attachments, if any, constitute confidential, proprietary information of Barlean's and shall not be used for any purpose other than the authorized advertising and sale of the Products nor disclosed to any third party without the prior written consent of Barlean's.

**EXHIBIT A**

**BARLEAN'S ORGANIC OILS, LLC  
PRODUCT CARE, CUSTOMER SERVICE, AND OTHER QUALITY CONTROLS**

1. Comply with all instructions provided by Barlean's regarding the storage, handling, shipping, disposal, or other aspect of the Products, including instructions provided on Product labels. Products shall be stored in a sanitary environment away from direct sunlight. Unless otherwise instructed by Barlean's, Products shall be stored at room temperature in a cool dry place and tightly capped. Products must be handled in accordance with good industrial hygiene and safety practices.
2. Sell Products in their original packaging. Relabeling, repackaging (including the separation of bundled Products or the bundling of Products), and other alterations to Products or their packaging are not permitted.
3. Do not remove, translate, or modify the contents of any label or literature on or accompanying the Products. Do not tamper with, deface, or otherwise alter any serial number, UPC code, batch or lot code, or other identifying information on Products or their packaging. Do not dilute Products.
4. Do not resell any Product that has been returned opened or repackaged.
5. Promptly upon receipt of the Products, inspect the Products and their packaging for damage, defect, broken seals, evidence of tampering, or other nonconformance (a "Defect"). If any Defect is identified, do not offer the Product for sale and promptly report the Defect to Barlean's at [orders@barleans.com](mailto:orders@barleans.com).
6. Inspect inventory regularly for expired or soon-to-be expired Products and do not sell any Products that are expired or that would expire prior to being fully consumed by the End User based on the total days' servings in the Product. Destroy or dispose of expired or soon-to-be expired Products in accordance with instructions provided by Barlean's and applicable law.
7. Be familiar with the special features of all Products marketed for sale and obtain sufficient Product knowledge to advise customers on the selection and safe use of the Products, as well as any applicable guarantee or return policy. Be available to respond to customer questions and concerns both before and after sale of the Products and respond to customer inquiries promptly.
8. Cooperate with Barlean's with respect to any Product tracking systems that may be implemented from time to time.
9. Cooperate with Barlean's with respect to any Product recall or other consumer safety information dissemination efforts.
10. Report to Barlean's any customer complaint or adverse claim regarding the Products and assist Barlean's in investigating any such complaints or adverse claims.
11. Cooperate with Barlean's in the investigation and resolution of any quality or customer service issues related to the sale of the Products, including disclosing information regarding Product sources, shipment, and handling.



**BARLEAN'S ORGANIC OILS, LLC**  
**UNITED STATES MINIMUM ADVERTISED PRICE POLICY**  
**Effective June 30, 2021**

Barlean's Organic Oils, LLC ("Barlean's") has determined that certain advertising practices undermine its trade reputation, brand, and premium image within the target consumer population and discourage its resellers from investing in the Barlean's brand and product lines and providing the best possible service and support to consumers. Accordingly, to protect the integrity of the Barlean's brand, Barlean's has adopted this unilateral Minimum Advertised Price Policy (the "Policy"), which applies to all authorized resellers of Barlean's Products in the United States of America.

The Policy applies to advertisements of the Barlean's products listed on the Barlean's MAP Schedule ("Covered Products"). The Barlean's MAP Schedule will be made available to all resellers and may be amended by Barlean's in its sole discretion at any time.

Barlean's is solely responsible for establishing the minimum advertised price ("MAP") for each Covered Product and communicating the MAP to all resellers. The MAP for the Covered Products is 25% off the Manufacturers Suggested Retail Price ("MSRP"). While resellers remain free to advertise and sell all Barlean's Products at any price they deem appropriate, it is a violation of this Policy for a reseller to advertise any Covered Product at a price lower than the MAP. Such advertisements include, but are not limited to:

- i. Offering coupons, discounts, reseller rebates, or other inducements that, when applied, result in a price lower than the MAP, including through use of a storewide sale, promotional code, or other similar provision that can be applied to Covered Products.
- ii. Bundling Covered Products with other products or services (whether made by or provided by Barlean's or another entity) in a manner that implies below-MAP pricing for the bundled Covered Product.
- iii. Strikeouts or strikethroughs of pricing information, "see price in cart," or other statements that suggest that a lower price for a Covered Product may be found at the final online checkout stage.
- iv. Permitting any third party to alter the advertised price for any Covered Product.

Direct or indirect attempts to circumvent this Policy also violate this Policy; however, it is not a violation to advertise that a customer may "call for price," "text for price," or "email for price" as long as no price is listed and no automated call, text message, or "bounce-back" email is used in response.

For purposes of this Policy, the terms "advertise" and "advertisement" include all promotional or pricing information displayed via any type of media, including, but not limited to, newspapers, catalogs, magazines, flyers, brochures, television, radio ads, billboards, signage (except signs

displayed within a brick-and-mortar selling location), websites, blogs, social media, affiliate marketing networks/comparison shopping engines, reseller-initiated text messages or emails to customers or prospective customers, mobile/smart phone applications, banner ads, online product ads, paid search ads, pay-per-click ads, display ads, mobile ads, product listing ads, sponsored links, ads in any other media in a digital format that is communicated or conveyed via the Internet, and any other marketing or promotional materials, whether displayed online or through broadcast or other media.

Notwithstanding the foregoing, pricing information displayed at the final online checkout stage of a transaction is not considered “advertising” under this Policy. The “final online checkout stage” is the stage when the Covered Product is put into a shopping cart that contains the customer’s name, shipping address, email address, and payment information. Pricing information in the “shopping cart” or “checkout” stages must be obscured technically so that it is not retrievable by shopping and pricing engines, and not displayed on search page results within the reseller’s own website.

From time to time, Barlean’s may announce MAP holidays or promotions that are applicable to all resellers, during which periods a reseller that advertises a Covered Product in accordance with the terms of the authorized promotion will not be deemed to have violated the Policy. Barlean’s will notify all resellers of any such authorized promotions, generally not fewer than fourteen (14) days in advance.

Further, the advertisement of free or reduced-price shipping is not a violation of this Policy as long as such offer applies to all or almost all other products offered by a reseller in the same product category.

**This Policy does not constitute an agreement between Barlean’s and any other entity.** Barlean’s neither solicits nor will it accept any assurance of compliance with this Policy from any reseller or other party. Each reseller must independently choose whether to comply with the terms of this Policy. This Policy is not negotiable and will not be altered for any individual reseller. This Policy applies only to advertised prices and does not affect the prices that a reseller may charge for Barlean’s Products.

## **NON-COMPLIANCE**

Barlean’s will take the following actions against any reseller that fails to comply with this Policy with respect to the advertisement of any Covered Product:

- i. For a reseller’s first violation of the Policy, Barlean’s will notify the reseller in writing of such failure and will issue the reseller a written warning. Continued violation for a period of seven (7) days from the date of the notice of the first violation shall constitute a second violation.
- ii. For a reseller’s second violation of the Policy within a six (6) month period, Barlean’s will notify the reseller in writing of such failure and will immediately place the reseller’s account on shipping hold for sixty (60) days. Barlean’s will revoke its acceptance of any pending orders, cancel any pending shipments to the reseller, and not accept any new orders from reseller during this 60-day period.

- iii. For a reseller's third violation of the Policy within a six (6) month period, Barlean's will terminate its business relationship with the reseller. Barlean's will revoke its acceptance of any pending orders and cancel any pending shipments to the reseller.

The Policy will be enforced by Barlean's in its sole discretion and without notice. Resellers have no right to enforce the Policy.

### **POLICY ADMINISTRATION**

Barlean's may update, revise, suspend, terminate, reinstitute, or modify this Policy at any time in its sole discretion. Barlean's shall make any such modifications available to all authorized resellers. If Barlean's changes the MAP on any Covered Product, it will provide at least thirty (30) days' notice to resellers before such change takes effect.

No employee or agent, including a sales representative, is authorized to modify, interpret, or grant exceptions to this Policy; solicit or obtain the agreement of any person to this Policy; or otherwise discuss any aspect of this Policy with any reseller, including that reseller's or any other reseller's compliance with the terms of the Policy. Any questions about this Policy should be submitted in writing and directed to Barlean's MAP Policy Administrator at [MAP@barleans.com](mailto:MAP@barleans.com). Barlean's will accept no other form of communication from resellers regarding the Policy.

This Policy is effective June 30, 2021 and supersedes all prior Barlean's policies and/or representations regarding minimum advertised prices or resale prices for Barlean's Products applicable to any reseller. To the extent that any provision, term, or agreement governing the relationship between Barlean's and any reseller may be construed in a manner that is inconsistent with the terms of this Policy, the terms of this Policy control.
